**LIABILITY RELEASE AGREEMENT**

**PLEASE READ CAREFULLY BEFORE SIGNING**

- I accept for use as is the equipment listed on this form and accept full responsibility for the care of the equipment while it is in my possession.
- I will be responsible for the replacement at **full retail value** of any equipment rented under this form, but not returned to Platform Ski Bike Rentals. (It is advised to never leave equipment unattended without a lock)
- I have watched the instructional video on use of my equipment (including loading/unloading equipment on chairlift) and fully understand its use and function. INITIAL: \_\_\_\_\_
- I have made no misrepresentation to the shop concerning my height or ski bike level.
- I understand ski bike rider must be at least 12 years of age and pass inspection by Platform Ski Bike Rentals to solely operate and handle equipment safely without the assistance of another person.
- I agree to hold harmless and indemnify Platform Ski Bike Rentals and its owners, agents, and employees, as well as the equipment manufacturers and distributors for any loss or damage, including any that result from claims for personal injury, death, or property damage related to the use of this equipment.
- I understand that there are inherent and other **risks** involved in the sport of ski biking, for which this equipment is to be used, that injuries are a common and ordinary occurrence of the sport, and **I freely and voluntarily assume those risks.**
- I understand that the ski bike leash is to be attached securely to the rider at ALL times, including while on chairlifts.
- ASSUMPTION OF RISK: I am aware that ski biking carries certain inherent risks, dangers, and hazards which can result in serious personal injury or death. I also am aware that the ski bike leash is not designed to prevent the inherent risks, dangers, and hazards which can result in serious personal injury or death. As such, I hereby freely agree to assume and accept any and all known and unknown risks of injury while using this equipment. I further recognize and acknowledge that the risks inherent in the sport of ski biking can be greatly reduced by: taking lessons, abiding by the Skier Responsibility Code (now known as "Your Responsibility Code") and using common sense.
